

ORDINANCE 2014- 01
FIRST AMENDMENT TO THE August 2008 OPERATING RULES AND REGULATIONS
GOVERNING WATER AND WASTEWATER FOR THE FOUR CORNERS COUNTY WATER
AND SEWER DISTRICT
(recreational vehicle sewage dumping sites and meters)

RECITALS

WHEREAS, the Operating Rules and Regulations (Rules and Regulations) by the Four Corners County Water and Sewer District were adopted in August of 2008 by the Four Corners County Water and Sewer District (District); and

WHEREAS, the District desires to amend the Rules and Regulations to amend to address the District accepting and charging for recreational vehicle and the like sewage as well as allowing for shut off of service.

WHEREAS, this Ordinance was published in the Bozeman Daily Chronicle once a week for two consecutive weeks on September 7 and September 14, 2014 and the Board considered the proposed amendment and all public comment thereon at the September 16, 2014 regular meeting.

WHEREAS, at the first reading, the published language of the proposed amendments to 8-4(1) and 2-9(1) were read aloud as follows:

8-4 (1) Any wastewater/effluent dumping site permitted for the disposal of recreational vehicle/camp trailers/ temporary mobile housing waste shall be considered a wastewater connection independent of any other connection approved on the property and shall be regulated pursuant to these Rules and Regulations. This section 8.4(1) is not applicable to wastewater/effluent dumping sites directly adjacent to and associated with developed RV pad sites within a licensed RV park.

2-9(1) For any wastewater only connection within the District, the owner shall install a shut-off and sewer meter line prior to commencement of service. The meter shall be purchased from Utility Solutions and inspected prior to turning on of service.

Jim Dolan, public and district owner, suggested modification to the proposed ordinance language. The Board agreed with Mr. Dolan's suggested modification to the proposed ordinance language.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE FOUR CORNERS COUNTY WATER AND SEWER DISTRICT that:

These provisions shall be added to the Operating Rules and Regulations by the adoption of the FIRST AMENDMENT TO THE AUGUST 2008 OPERATING RULES AND

REGULATIONS GOVERNING WATER AND WASTEWATER FOR THE FOUR CORNERS COUNTY WATER AND SEWER DISTRICT as follows:

8-4 (1) Any wastewater/effluent dumping site permitted for the disposal of recreational vehicle/camp trailers/ temporary mobile housing waste shall be considered a wastewater connection independent of any other connection approved on the property and shall be regulated pursuant to these Rules and Regulations. This section 8.4(1) is not applicable to wastewater/effluent dumping sites directly adjacent to and associated with developed RV pad sites within a licensed RV park.

2-9(1) For any wastewater only connection within the District, the owner shall install a shut-off and sewer meter line prior to commencement of service. The meter shall be purchased from a District or an appointed vendor and inspected by the District (or its approved representative) prior to connection and commencement of service.

First reading approved unanimously on September 16, 2014.

Second reading ~~approved~~ denied by a vote of 4-0 on October 21st, 2014.

THIS ORDINANCE SHALL BE EFFECTIVE 30 DAYS AFTER SECOND READING.
